



**OUR LADY OF LOURDES RELIGIOUS EDUCATION  
ENROLLMENT POLICY  
YEAR OF 2009-2010**

In exchange for the religious education provided by Our Lady of Lourdes Catholic church, Parent(s)/guardian(s) agree to the following religious education enrollment policy.

The religious education tuition for children of parish members, **registered and in good standing**, attending Our Lady of Lourdes Religious Education Program is as follows:

Grade 1-11	\$105.00
Sacramental Fees:	
First Reconciliation	\$20.00 per student
First Eucharist	\$30.00 per student
Confirmation	\$35.00 per student
Full expectation of church dues.	

**Every family MUST sign an enrollment contract. If no contract is on file in the Parish Office, enrollment had not been established.**

**All religious education tuition and the full, fair share of church dues must be paid if parents(s)/guardian(s) plan to enroll their child(ren) in the educational programs for the 2009-2010 school year. The religious education tuition is to be paid according to the established payment schedule and the church dues must be paid in full by June 30, 2009. A family will be charged all R.E. fees based on previous contribution levels.**

**The established fees for 2009-2010 ASSUME that the families are registered members of Our Lady of Lourdes Parish who are practicing the principles of stewardship – regular attendance, serving the parish community as a volunteer and supporting the parish and its ministries monetarily. Those families who are not practicing stewardship will need to establish their enrollment through the Parish Office. To establish enrollment, please call either Fr. Tim or Lynn Meulemans at 336-4033. Families should not ASSUME that enrollment is completed and accepted if they complete an enrollment form and send in the registration fees. Those families who do not meet the stewardship requirement will be notified prior to establishing enrollment.**

**PAYMENT SCHEDULE:**

Total tuition payable with signed enrollment/contract by May 15.

**NO PARISH MEMBER WILL BE TURNED AWAY FROM THE SERVICES OF OUR LADY OF LOURDES IF THE CONTRIBUTION SCALE CANNOT BE MET. PARISH FAMILIES UNABLE TO MEET THE TERMS OF THIS CONTRACT (R.E. TUITION AND CHURCH DUES) ARE ASKED TO CALL FATHER TIM OR LYNN MEULEMANS ABOUT THEIR SITUATION OR REQUEST A FINANCIAL CONSIDERATION FORM. (All financial consideration is strictly confidential.)**

Families requesting financial assistance will be required to apply for any scholarship monies available e.g., St. Vincent de Paul, etc. Application forms are available in the parish office.

A SCRIP incentive Program is available to all parent(s) of Our Lady of Lourdes students. Any parents(s) wishing to use SCRIP dollars (gift certificates) to buy groceries, do shopping, purchase gas, eat in restaurants, etc. will benefit directly by having a set percentage of the profits made by SCRIP go directly toward their religious education tuition. Your registration form indicates your credit as a result of your participation in this program (This amount will not be available until mid April). A complete program description can be obtained by calling the R.E. Office.

In the event of expulsion or withdrawal of the child(ren), the parties agree that the religious education fees shall be pro-rated to the date of expulsion or withdrawal.

The enrollment/registration contract shall be legally binding and fully enforceable in a court of law.

Parents are encouraged to keep this religious education enrollment policy for their records.
